On May 20, 1952, five black officers gathered in Durham, N.C. and decided to organize an association to promote professionalism in police work and to further the utilization of minorities in law enforcement. At that time, the organization was known as N.C. Negro Law Enforcement Officers Association. The name of the organization was later changed to North State Law Enforcement Officers Association.

North State Law Enforcement Officers Association is a non-profit organization devoted to furthering the education and training of minority law enforcement officers.

The NSLEOA is the only organization in North Carolina which unites every branch of law enforcement. All are eligible for membership, regardless of rank, assignment or department affiliation.

Yearly training conferences are held in June which serves as a forum for the exchange of ideas.

The objectives are:

- To maintain law enforcement work as an honorable profession.
- To bind members in close bond in order to promote the best interest for the common good.
- To strive toward true professionalism by preparing through education and training to keep abreast of current theories and techniques in the interest of better serving the public and the profession.
- To secure closer official and personal relationship among minorities in law enforcement.
- To secure merited recognition of minority law enforcement officers and their work.
- To increase and enhance minority performances through shared experiences.
- To work towards eliminating police brutality and racial discrimination.

Several hundred officers, (Men and Women) have bound themselves together through NSLEOA to ensure that a just atmosphere prevails for all a law enforcement officers. In order to obtain or maintain membership in NSLEOA, and individual must be affiliated with and be in good standing with an approved chapter. The eleven chapters are: Eastern, Cape Fear, Capital, Charlotte, COFFEE, Furniture, Gate City, Gaston Co. Southern, Triangle, Winston-Salem/Forsyth Co. and an Auxiliary.
